

Cary's Instructions for Tax Court Remedy

Step 1: Petition Forms

1. Download the document titled "Petition Kit Sample". This form has been filled out properly with the exception of your particular information. Fill in your name at the top.
 2. On number 1, check the boxes that state: "**Notice of Deficiency and Notice of Determination for Collection Action.** "
 3. On number 2 write: N/A - Never received Notice of Deficiency, or Notice of Determination Concerning Collection Action
 4. On number 3 write in: N/A - never received for 2000 to 2017. (Unless your issues go beyond the year 2000)
 5. On line 4 select the box that states: "**If you want your case conducted under regular tax case procedures, check here:**"
 6. On line 5 write: N/A - Never received Notice of Deficiency for years 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, and 2017. Also never received Notice of Determination Concerning Collection Action for years 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, and 2017.
 - 7 On line 6, repeat above: Never received Notice of Deficiency for years 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, and 2017. Also never received Notice of Determination Concerning Collection Action for years 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, and 2017.
 - 8 On the Enclosures sections check: Statement of Taxpayer Identification Number (Form 4) (See PRIVACY NOTICE below) and The Request for Place of Trial (Form 5).
- NOTE: The instructions page of this form will be used for the mailing address of the court ONLY!!! Do not use the remaining instructions and most important of all DO NOT pay the \$60 filing fee!. If you do, the payment will change the jurisdiction and you will lose!**
9. Fill in the remaining blanks that ask for your name, address phone number and email address, if you wish. All other blanks place an N/A so as to clear up any confusion as to your intent. Be sure to sign and date.

Statement of Taxpayer Identification Form

1. Fill in your name and social security number where it asks. Place an N/A on any unfilled blanks so as to clear up any confusion as to your intent.
2. On the Joint return statement, place "N/A - Never Received"
3. Sign and date.

Request for Place of Trial Form

1. Fill in your name.
2. Find your state and select the city that is closest to you that does **NOT** have an Asterisk (*) next to it.
3. Sign and date.

Mail In

Mail in package to the tax court address listed on the instructions page on the petition form. Mail by any way you desire; first class, certified, certified return receipt or registered mail. Anyway is fine.

Response from the Court or Attorneys

Step 2: Sample Letter to Clerk of Court

Fill in your name and address and mail off to the clerk of court. This letter is to establish that the US District courts do not have any jurisdiction of you in regards to IRS matters. You may have to send this letter off many times until you receive the desired response that states that the courts do NOT have jurisdiction over the IRS.
